Business representatives met with Police Minister. Since the issuance of our Circular 002, there have been a total of xx queries from businesses right across the country. MOVEMENT OF PERSONS FROM INTERNATIONAL FLIGHTS AND PROVINCES		
Query	Response	Action Item
Awareness of PMV Operators.	State Controller will deploy officials for awareness to PMV operators.	PMV operators are encouraged to refuse passengers that have flu symptoms and also sanitise busses. State Controller will issue awareness and provide Personal Protective Equipment. This will be relayed to the relevant PMV business associations.
Issuance of NOC 19 Photo IDs to crews traveling on land during SOEs.	For tracing purposes, these IDs will be issued to crews of logistical companies. It was further highlighted a maximum of 4 crew per truck.	Work with business reps so that all logistical companies submit crew details.
Employees that show signs of COVID 19 symptoms.	They are NOT to travel to hospitals and will be refused access.	Management to apply the protocol to self isolate and to contact 180 0200 for Response Unit to check employee.
